COVID-19—A National Emergency Declaration

The President of the United States has made funds available through the FEMA Public Assistance (PA) Grant Program in support of life-saving Emergency Protective Measures related to COVID-19. Pursuant to Sec. 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the “Stafford Act”) . FEMA is directed to assist state, local, tribal, territorial governments and other eligible entities with the health and safety actions they take on behalf of the American public using **Emergency Protective Measures**.

Public Assistance Program Grants Aid in Providing Emergency Protective Measures

Eligible emergency protective measures taken at the direction or guidance of public health officials in response to this emergency, and not supported by the authorities of another federal agency, will be reimbursed strictly under the FEMA **Public Assistance** program., and in accordance to the [Public Assistance Program and Policy Guide](#) (PAPPG). FEMA assistance will be provided at a 75 percent Federal cost share.

Saving Lives and Protecting Public Health and Safety

Public Assistance **emergency protective measures** and associated costs that are eligible to save lives or protect public health or safety include but are not limited to:

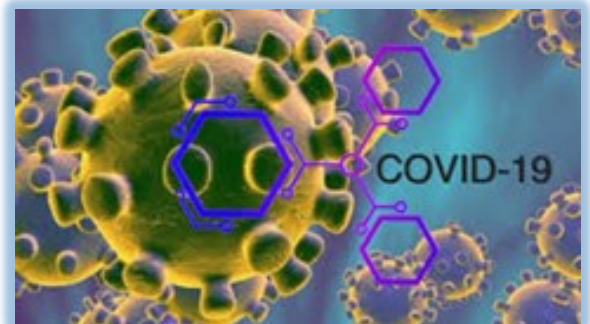
- Emergency Operations Center costs
- Management, control and reduction of immediate threats to public health and safety
- Emergency medical care
- Medical sheltering (e.g. when existing facilities are reasonably forecast to become overloaded and cannot accommodate needs)
- Purchase and distribution of food, water, ice, medicine, and other consumable supplies, to include personal protective equipment and hazardous material suits
- Movement of supplies and persons
- Security and law enforcement
- Communications of general health and safety information to the public
- Reimbursement for state, tribe, territory and/or local government force account overtime costs
