- b) Bo reminded the VEMA Board of the logistics required to host a VEMS conference. With COVID-19 proceeding he suggested that the VEMA Board make a final decision on virtual versus in-person for VEMS 2021 no later than the November board meeting. Robert Foresman established an ad-hoc committee who will make a recommendation on VEMS 2021 in October. The ad-hoc committee will be chaired by Bobby Gelormine and made up of the VEMA Executive Board members, Jeff Fletcher, Jared Hoerning, Melanie Fleenor, Danielle Progen and 2-3 additional regional coordinators.

Under Good and Order, the VEMA discussed moving the November 11th board meeting to another date as November 11th is Veterans day. Robert Foresman will get with the VEMA office to determine a new date.

There being no further business the meeting was adjourned at 11:14 am.
