#### **Application Tips:**

In reviewing application packets one of the areas that seems to give applicants the hardest time is documenting training history. Below are some tips to help navigate that portion of the application.

- For the initial application, training must have occurred within the past ten years. For recertification, training must have occurred within the last certification period.
- Provide course documentation (i.e. the certificate of completion) in the same order the information is listed on the Training Summary Form.
- Applicants are required to submit both emergency management and general management training hours. The number of hours varies based on the level of certification. It is the applicant's responsibility to ensure the training listed adequately reflects these requirements and that the training falls within the appropriate category.
- A training allocation table is available to help applicants determine how to allocate the training courses. Some courses can be listed as either general management or emergency management. However, the course can only be used once in the application. For example, ICS 400 for Command and General Staff can count as 16 hours under either Emergency Management or General Management. An applicant should not list ICS 400 under each category.
- Other courses fall as either emergency management or general management and should be listed within the appropriate training summary within the application. Applications that list general management hours for emergency management and vice versa, as well as applications that do not provide adequate documentation such as a course certificate and/or a training submission form may be returned.

One of the most frequently relied upon contributions is that of membership with an emergency management related professional organization. As expected, many applicants are VEMA members. Please do not assume the Committee will automatically recognize membership. It is the applicant's responsibility to document proof of membership. This can be done by providing a copy of the paid membership invoice or an email from the VEMA Office noting membership.

#### CIVIL AIR PATROL RESPONDS TO FLOODING

#### The Situation

The last week in September saw Virginia faced with the prospect of dangerous and unsettling weather. A storm system from the west was threatening heavy rain across the state while Tropical Storm Joaquin was threatening to grow into a hurricane and approach the Mid-Atlantic coast. As the threat solidified, Gov. McAuliffe declared an emergency on September 30th and Virginia began to prepare for the worst. Among those who responded to assist was the Virginia Wing of the Civil Air Patrol.

#### The Civil Air Patrol

The Civil Air Patrol (CAP) is a Congressionally chartered corporation that serves as the volunteer auxiliary of the US Air Force. CAP has a long history of assisting the country and the Commonwealth. Formed at the start of World War II, CAP provided anti-submarine patrols along the East and Gulf coasts well into 1943. One of their patrol bases was set up in Accomack County in 1942. Since the war, CAP has trained thousands of young people as cadets, conducted countless aerospace education activities, and assisted federal, state, and local governments in search and rescue operations and response to disasters.

With some 58,000 volunteer members and 550 aircraft, CAP has proven to be of substantial assistance in the response to major disasters. CAP volunteers and aircraft from 25 states responded to Hurricane Katrina. CAP volunteers and aircraft from most of the East Coast and as far west as Michigan responded to "Superstorm Sandy". While aerial reconnaissance has always been one of CAP's post disaster response skill sets, the response to Sandy saw the first major effort at digital photography in such a response. CAP volunteers took 160,000 geo-tagged photos for FEMA in that mission.

The Virginia Wing (VAWG) of CAP provides CAP services to the Commonwealth. We have 1900 volunteer members and 12 aircraft assigned. Most Virginia Wing members serve in the 23 local squadrons that are located throughout Virginia. VAWG also operates a statewide VHF radio network, multiple HF radio stations, and five portable communication caches. Included in the VAWG equipment inventory are 12 high-definition, digital cameras with a GPS interface so they can show the time, location, the aircraft's direction of travel and aircraft altitude on each photo taken. CAP also has a long-standing MOU with VDEM to provide assistance in an emergency.

#### Response to the Current Weather Event

With the approaching storm, the VA EOC went to enhanced operations on September 29th. And the rains began throughout much of Virginia. Joaquin, now a hurricane was projected to turn north after dawdling over the West Indies and the Bahamas for several days. The projected tracks suggested serious strengthening and landfall between the Outer Banks of NC and the MD coast later in the coming weekend.

Ultimately, parts of SW VA received over 6" of rain and suffered serious flooding. Cresting river surges posed serious threats downstream into the weekend, and the rain continued. In the meantime, Hurricane Joaquin increased in strength to Category-5 storm but fortunately, veered farther and farther away from the US mainland. Despite the expected miss by the hurricane, its effects from rain and a tidal surge was still expected.

#### Civil Air Patrol—Page 2

On October 2<sup>nd</sup>, VDEM requested that CAP provide a liaison officer to the VEOC with the expectation that CAP would provide aerial reconnaissance and photography support as soon as the weather would permit. The Virginia Wing (VAWG) provided a liaison officer in the EOC starting that evening and continuing until the following Tuesday (Oct. 6<sup>th</sup>).

VAWG also stood up a basic mission management team and started the mobilization process. The initial response to the request was to activate our statewide radio communications systems (VHF and HF) to insure they were available and operating properly. Our Operations staff had insured that all of our aircraft were in safe locations for the storm event. They began to insure their availability and maintenance status for the coming mission. (All 12 VAWG aircraft were fully mission capable by the 3<sup>rd</sup>. Then we began to mobilize air crews for possible tasks as soon as the weather cleared enough to fly (predicted to be Monday, Oct. 5<sup>th</sup> or Tuesday, Oct. 6<sup>th</sup>). By that Sunday, most VAWG aircraft had crews on standby for quick response. Ultimately, we received 4 tasks through WEBEOC. One of these (from the Army Corps of Engineers) to fly storm surge/damage assessment (with photos) along the VA coast by Virginia Beach. The others were from VDEM and local emergency managers to fly photo recon along flooding rivers in Floyd, Roanoke, and Patrick counties.

All tasks were completed on Tuesday, Oct. 6th after the weather cleared enough to safely launch aircraft. CAP aircraft flew out of Hampton Roads, Charlottesville, and Danville to perform these tasks. A total of 8 sorties were flown by these aircraft. Over 50 pictures were taken which were provided to the customers through VDEM.

VDEM told VAWG to stand down on Wednesday, October 7<sup>th</sup> and we did so. However, we didn't stop. VAWG immediately dispatched four aircraft and crews to South Carolina to assist the South Carolina Wing in their response to much more serious flooding (parts of SC had received over 12" of rain from the same event. In this, we were joining aircraft from the Maryland, North Carolina, and Georgia Wings in assisting South Carolina.

#### The Future

In most of the CAP aerial photo missions to date, we have used manually operated cameras operated by trained aerial photographers. Most of our aircraft have special windows that open to allow the camera to shoot pictures without shooting through the window. However, CAP continues to explore other imagery options in conjunction with the Air Force and FEMA. CAP recently purchased a number of aircraft mounted, GPS enabled, remote operated cameras. These cameras will shoot pictures straight down instead of at an angle and will provide better photographs and GPS position coordinates. VAWG will be receiving 8 of these cameras in the next few months. Other technology improvements will certainly follow.

The 2016 Virginia Emergency Management Symposium Committee is excited to share that this year's keynote closing speaker will be Dr. David Griffin with Charleston, SC Fire Department.

David Griffin, 35, was the driver of the first engine to respond to the disastrous 2007 Sofa Super Store fire that claimed the lives of nine of his fellow firefighters. Plagued with survivor's guilt, he numbed himself with alcohol, painkillers, and blood sports so much so that it nearly cost him his life. A turning point came in the days following a match with nationally ranked mixed-martial arts contender Houston "The Assassin" Alexander. For three days, he sat in darkness; his eyes swelled shut from the battering to his face. He asked himself how his lifestyle honored the nine who were dead. "One can only sit around for so long and feel sorry for themselves until they have to get up and do something," Griffin said.

Now Griffin has completed a Doctorate of Education in organizational leadership and development, training firefighters around the world. He speaks about the Sofa Super Store fire across the globe and has helped with massive reforms in how firefighters are trained. Griffin has dedicated his life to ensuring the tragedy never repeats itself.

Griffin is a certified Chief Training Officer (CTO) and Fire Officer (FO) through the Center for Public Safety Excellence (CPSE) and is currently a student in the Executive Fire Officer Program at the National Fire Academy. He was a featured speaker at the Fire Department Instructors Conference in Indianapolis, Indiana, the keynote speaker at the National Fallen Firefighters Tampa 2 Summit, the keynote speaker at Firehouse Expo, the keynote speaker at the International Association of Fire Chiefs Volunteer and Combination Officers Symposium, the keynote speaker at the Indiana Emergency Response Conference, the keynote speaker at the Florida Fire Chiefs Safety and Health Conference, and the keynote speaker at the Maryland Firefighters Association Conference, to name a few.

Griffin's bestselling book, <u>In Honor of The Charleston 9</u>: A Study of Change Following Tragedy, was released November 2013. His latest book, <u>ACTION</u>: 9 <u>Missions for Personal and Professional Growth</u>, was released on November 9, 2015. He is also currently writing a third book about his experiences that has brought him to where he is today. He and his wife, Melissa, live in Charleston, SC with their Great Dane –Lulu.

#### First Responder Operations Software

#### Incident Management Preparedness and Coordination Toolkit

#### Project Description

As with many professions, safety planners and first responders tend to be specialists in certain areas. To be truly useful, tools should be tailored to meet their specific needs. Thus, general software suites aimed at the professional geographic information system (GIS) community might not be the best solution for a first responder with little training in GIS terminology and techniques. On the other hand, commonly used web-based map viewers may not have the capability to be customized for the planning, response, and recovery (PR&R)



mission. Data formats should be open and foster easy information flow among local, state, and federal partners. Tools should be free or low-cost to address real-world budget constraints at the local level. They also need to work both with and without a network connection to be robust. The *Incident Management Preparedness and Coordination Toolkit* (IMPACT) can satisfy many of these needs while working in harmony with established systems at the local, state, and federal levels.

#### Technical Approach

The IMPACT software framework, termed the Geospatial Integrated Problem Solving Environment (GIPSE), organizes tasks, tools, and resources for the end user. It uses the concept of software wizards to both customize and extend its functionality. On the Tasks panel are a number of buttons used to initiate various operations. Similar to macros, these task buttons launch scripts that utilize the full functionality of the underlying foundational components such as the PostgreSQL spatial database and ORNL-developed map editor. The user is presented with a series of instruction pages which are implemented with HTML for interactivity. On each page are links which initiate specific actions such as creating a map



showing various features. Additional tasks may be quickly programmed and added to the panel. The end user can customize the graphical interface to facilitate its use during an emergency.

One of the major components of IMPACT is the ORNL Geospatial Viewer (OGV). It is used to provide various map displays for the Tasks and Maps panels. Unlike typical maps however, the OGV display is highly interactive and can be customized, automated, and animated to meet the needs of the user. It is also a means to both import and export geospatial data from or to existing GIS systems. The built-in simulation capability can be used as the basis of table-top exercises.
