



VEMA STRATEGIC PLAN FY26 – FY28

(July 1, 2025 – June 30, 2028)

INTRODUCTION

The Virginia Emergency Management Association was founded in 1963 to promote, support and advocate for emergency management in Virginia. The Constitution and its associated By-Laws were drafted and adopted to provide the framework and guidance of the Association.

Mission Statement - “To promote, support and advocate for emergency management in the Commonwealth of Virginia.”

Vision Statement - “The recognized expert and advocate for excellence in the management of emergency preparedness, response, recovery, and mitigation throughout the Commonwealth of Virginia.”

Purpose: The purposes of this Association shall include the following:

- To promote a professional emergency management organization comprised of all disciplines of emergency management within the Commonwealth of Virginia.
- To promote an all-hazards approach to emergency management throughout the Commonwealth among individuals, neighborhoods, communities, businesses, schools, institutions of higher education, non-government agencies, faith-based organizations, military, and government at all levels.
- To promote and enhance whole community emergency management throughout the Commonwealth of Virginia.
- To support the continued growth of emergency management through participation in studies, research throughout the Commonwealth of Virginia. Promoting the collection of, compiling, and disseminating the results of those studies and research.
- To monitor the legislative process and the decision-making processes of the state regulatory agencies as they relate to the interests of the membership, and to keep the membership informed of the same.
- To develop, sponsor, promote, conduct, and participate in educational programs including workshops, seminars, conferences and exercises in the field of emergency management.
- To promote the professional development and recognition of emergency management as a profession through training, education, and experience-based certification program.
- To work with and assist the Virginia Governor’s Secretariat of Public Safety and Homeland Security, the Virginia Department of Emergency Management, the Federal Emergency Management Agency, and other state, national, or international associations or groups on matters of mutual interest or benefit; and
- Other purposes which the membership deems worthy and necessary to further the Association.

Summary of Current Status

VEMA's Board of Directors is comprised of two representatives from each VDEM Region, a state, federal, military, private, and student sector representative, and a representative from each of the three caucuses: Institutions of Higher Education (IHE), Faith Based, and Healthcare.

As of April 30, 2025, VEMA has 423 memberships for a total of 789 bodies which is a change of -3.2% in membership and -1.4% bodies from April 30, 2024. The reason for the decrease after two years of increase in membership could be due to the current federal climate and restrictions on government purchasing. The VEMA Office tracks quarterly membership numbers year over year dating back to the 2018-2019 fiscal year.

Over the past three years, a few elements were identified for improvement most notably:

- Keeping committees engaged and active.
- Rebuilding the Membership and Marketing committee.
- Increasing activity on social media to build brand and visibility.
- Refocusing Board meetings from report outs to current and future business.
- Expanding our professional network.
- Continuity of operations.
- Enhancing and highlighting membership benefits.

The Association was successful in making improvements to all areas. Over the past three years, the Association has:

- Reformed the Membership and Marketing committee with a larger leadership structure to make it more manageable and have included the Professional Development ad hoc committee as a subcommittee of Membership and Marketing like social media.
- Purchased a CANVA account to assist with branding and visibility.
- Implemented a year-round sponsorship program to provide more opportunities for revenue generation outside of the annual symposium vendors and sponsors.
- Introduced legislation in the General Assembly and have taken a more proactive stance in engaging with elected leadership outside of Lobby Day.
- Started to evaluate and update the certification policy to create value to the emergency management professionals within Virginia.
- Realigned officer roles and responsibilities pertaining to committee responsibility to ensure equitable responsibility.
- Encouraged all committees to have a vice chair to promote continuity and continued operations.
- Increased membership types to promote inclusion of new professionals, non-profits, and smaller organizations that have limited financial means.

The strategic plan for FY 26 – FY 28 will continue to capitalize on the work already started and elevate the association to a new height. This strategic plan was created through an ad hoc committee and all Committee chairs and Board Members had the opportunity to provide input.

VEMA STRATEGIC PLAN FY 26 – FY 28

Goal 1: To promote the development of emergency management professionals across all stages of their career.

September 1.

- The VEMA Executive Committee will develop and disseminate a survey to all members in May of every year to gather feedback on members' satisfaction of the Association and whether they are intending on renewing their membership for the next year. Feedback will be used to develop strategies for areas of improvement for the next year.
- Analyze current membership trends and provide recommendations to the Board for growing and sustaining membership.
